

2020 Grant Application

Award information

Awards must be used for direct costs of research being conducted in connection to an academic degree program at an institution of higher learning. Applicants can be students in the United States or an International location. We define "student" broadly, and could include postdoctoral fellows, residents, or interns, as long as they meet all other requirements (e.g., IRB oversight, faculty mentor, etc.). Research projects must be designed to examine the epidemiology, phenomenology, and/or clinical/community/cultural/environmental contexts of psychedelic substances. Studies can also be designed to examine pre-clinical questions about the effects of psychedelic substances. Direct costs include (but are not limited to) participant incentives, computer software, office materials, fees for consultants/piecework, and a portion of the award will be specifically designated to be used for travel to present findings to a national or international scientific meeting/conference (poster or oral presentation). Ideally, the meeting/ conference will be attended by an SRF Board member to facilitate an in-person connection with SRF. Funds may *not* be used for personnel costs. Applicants may apply for awards more than once and there is no limit to the number of individual awards that an applicant may be awarded during the course of their training. Funds must be used within 1 year. If more time is needed, then the awardee must submit a request for an extension to SRF. International applicants must include currency conversion rates and present their budget in US dollars. Any fees associated with international wire transfers must also be included in the budget. Lastly, any funds already received or solicited for a project must be declared at the time of application. Applicants are eligible to combine funding so long as they specify how SRF funds will supplement other funding sources.

Submission Deadline & Notice of Award

Applications are due by 8pm eastern standard time on June 1st 2020. Applications received after this time will not be considered. Awards will be announced by September 1st 2020.

Review Committee & Review Process

Each application will be reviewed by our Application Review Committee. Each reviewer will rate the application using a standard form. Ratings are based on the quality and innovation of the study design, the merit of the applicant and their academic mentors, its relevance to the mission of SRF, and the likelihood of successful completion of the study. Once ratings are compiled, the Board of Directors will meet to discuss the merits of the highly ranked applications and vote on which should be selected for funding.

Diversity Invitation

Individuals who identify as a member of a diverse ethnic, racial, gender, religious, or sexual orientation group are especially encouraged to apply. Studies that are designed to address gaps in our understanding of the ways in which the experience of diversity as it relates to psychedelic science and examining psychedelic substance use, or the cultural, environmental, and clinical applications of psychedelics among diversity population are also highly encouraged.

Additional Application Materials

Depending on the stage of your project, one of the following sets of additional documents are also required. Choose which stage your project is in and then check the box next to that stage to confirm that you have prepared the documents and sent them with this application.

Proposal stage:

Projects in the proposal stage (i.e., pre-IRB or academic committee approval) must be approved by the primary research mentor and/or the committee that is overseeing the project, as evidenced by a letter on institutional letterhead from your primary mentor stating that the project has been approved and is in process of seeking IRB approval. If changes to the study occur as part of the IRB approval process, then an updated proposal must be submitted for expedited review and approval at SRF. If accepted for an award, and after the protocol is approved by the local IRB, the applicant must submit the final IRB approval letter to SRF on condition of receiving the award.

Data collection stage:

Projects in the active data collection stage (post-IRB approval and preparing to recruit or actively recruiting or conducting the study) are eligible for awards, however, the application must be accompanied by the final approval letter from the IRB at the applicant's institution of higher learning and, in addition to the materials noted above, the applicant must include a brief summary of the status of recruitment or study completion at the time the application is submitted.

Data analysis / manuscript writing stage:

Projects at this stage (all recruitment and data collection activities are completed) are also eligible for awards. Applications must be accompanied by the final IRB approval letter and, in addition to the materials noted above, must include a brief summary of the participant characteristics (i.e., a flow chart of recruitment and table of main sample characteristics) and a summary of the primary results.

Completed projects:

Projects that are completed within one year of the application deadline are eligible for awards. Applications must include the final IRB approval letter and, in addition to the materials noted above, a summary of primary findings (e.g., this could be a manuscript or thesis/dissertation document), and a list of presentations/publications that have come from the project. In order to apply at this stage, applicants must also include a secondary analysis section that details a new way in which the data will be examined. Funds can also be used to fund a translational aim of a completed project. Such translational aims could include the use of the data to inform public health, intervention, or other educational/environmental/community endeavors. If applicants are seeking funds for a translational aim of a completed project, then application documents must include specific aims and plan for this secondary project and the justification for any new expenses.



Awardee Agreement

Each SRF awardee must agree to the following criteria, which is conditional upon receiving any award from SRF. Please check the box next to each criterion, acknowledging that you have read each statement and will agree to each as part of any award you might receive from SRF.

All funds will be used in accordance with the budget that is approved by the foundation.

Any changes to the budget must be approved by the President of SRF.

The awardee will submit a progress report every 6 months after the award notification until such time as the project is completed. Future reimbursement of funds is conditional upon timely submission of progress reports. The awardee has 1 year to use funds and must submit request to extend timeline if funds are not used by that time. Any unused funds will be re-allocated to SRF for future grant awards.

Upon completion of the project the awardee will provide a summary of the findings to SRF. If the project has already been completed, then the summary of findings is required at the time of funds disbursement.

The awardee agrees to present the findings from the project in one of the following formats (research conference or scientific meeting, peer reviewed publication, editorial publication).

The awardee agrees to list SRF as a funding source for the project in any/all presentations, publications, or other forms of dissemination that come from the project as well as in the official written report of the degree program (i.e., thesis, dissertation)

The awardee agrees to uphold the ethical obligations of institution where they are enrolled and from where the study has been approved (or is in the process of becoming approved). Any changes that occur to the project must be communicated to SRF.
